

CALL TO ARTISTS

Project Overview

Public art can be a change agent for the community. It creates and enhances neighborhood and community identity. It enhances the visual landscape and character of the city. It turns ordinary spaces into community landmarks and promotes community dialogue and, most importantly, it is accessible to everyone.

Coeur d'Alene is one of the West's premier four-season destinations for business meetings, leisure travel and special events. Coeur d'Alene is located on the shore of one of the world's most beautiful lakes and is a special community enjoying an outstanding natural setting that people in most places only dream about.

The Coeur d'Alene "ArtCurrents" program consists of sculptures on loan from artists residing in the Pacific Northwest. Artists submit applications for placement of their sculptures around the Coeur d'Alene area for a period of one (1) year, including thirteen (13) sculptures in downtown Coeur d'Alene, and five (5) sculptures in the Riverstone area. Applications must include photographs of the submitted work taken from the front and back viewpoints. From the submissions a committee will select the pieces to be installed. The one year period will run from the beginning of October through the end of September of the following year.

Throughout the year Coeur d'Alene has major events that attract thousands of people. Events such as Car d'Lane, Art on the Green, CDA Street Fair, Art in the Park, Ford Ironman Triathlon, The Chocolate Affair, Dog d'Alene, Oktoberfest and the monthly Coeur d'Alene Art Walk, to mention a few. With over 250,000 people attending these events and visiting Coeur d'Alene, there are many potential buyers who will be viewing the art.

The Artwork

The minimum size of the artwork must be 36" tall or larger and must be designed and fabricated for long-term outdoor durability and ease of maintenance, including potential vandalism. We look forward to artistic interpretation and creativity in this call.

Budget and Payment Schedule

The artists selected will be paid a stipend of \$1,000.00 after receipt of the artwork. The artist will be responsible for transporting the artwork to and from its present location and for any costs associated with the transport of the artwork. Temporary plaques with the name of the art piece and purchase information will be included with each installation. The displayed art pieces will also be offered for sale with the City of Coeur d'Alene receiving a 25% commission from the sale. Pieces that are purchased by individuals or businesses and then donated back to the city will be relocated to an appropriate permanent location within the city limits.

ArtCurrents Selection Process

Responses to this "Call to Artists" will be evaluated by a selection committee consisting of members of the Arts Commission, a councilmember, a member of the Downtown Association, and other members as determined by the Arts Commission. Selection criteria to be used for consideration shall include, but not be limited to the following: Artistic quality, context, compatibility with a site, materials' suitability and safety, possible contribution to the City's public art collection, public safety, environmental impact, media, diversity, feasibility, and duplication.

Submissions should include two or more digital images taken from front and back viewpoints, and installation requirements. The selection panel will select up to eighteen (18) pieces, which will be submitted to the Arts Commission for approval. Before the selected art work can be placed, a contract for artist/galleries must be completed and signed, which constitutes the entire contract between the artist and/or gallery submitting the artwork.

Onsite installation to be scheduled during the month of October, 2017.

Submission Requirements

Applications must be received through the CaFÉ website (<u>www.callforentry.org</u>) no later than 5:00 p.m. PST on June 30, 2017. The call is entitled: "City of Coeur d'Alene, Idaho - ArtCurrents 2017."

Eligibility

The project is open to all artists residing in the states of Idaho, Montana, Washington and Oregon regardless of race, color, religion, national origin, gender, age, marital status, or physical or mental disability, etc. Artist teams are eligible to apply, including teams of artists from multiple disciplines. Selection panelists and their immediate family members are not eligible for participation.

The City of Coeur d'Alene reserves the right to change the dates of the project timeline, to modify this solicitation, to request additional information or proposals from any or all participating artists, to re-open the competition and/or to accept or reject, at any time prior to the commissioning of a work, any or all design proposals.
