
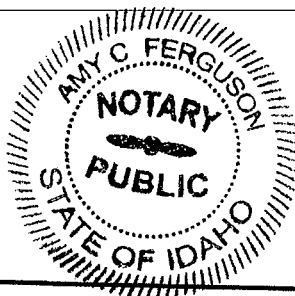



# Declaration of Candidacy



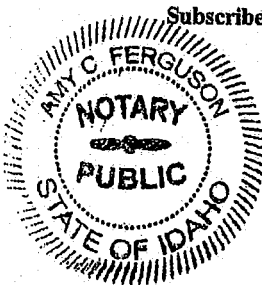

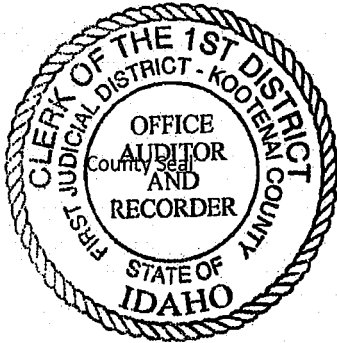
