


Declaration of Candidacy

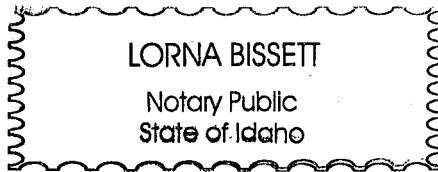


