Burglary - Resid (1): W Marie Ave. - Two juveniles broke into a vacant apartment and vandalized it. Case active.

Theft (2): 1316 N 4th St; Pilgrim's Market - A wallet was lost and turned in to an employee. Upon the owner's return, they discovered \$200 missing from it. 320 Sherman Ave; Pita Pit. - A suspect was arrested for stealing food.

<u>Vehicle Theft (1):</u> <u>E Sherman Ave.</u> – The victim reported their vehicle stolen. However, it was found two blocks away with money and a firearm still inside. The victim remains confident in the theft. Case remains active.
