Point in Time Count Results

Definition of Homeless

1. Unsheltered homeless person resides:

In a place not meant for human habitation. Included in this count are people in temporary tents or armory shelters, encampments, and warming centers.

2. A sheltered homeless person resides:

In an emergency shelter or in transitional housing or supportive housing for homeless persons who originally came for the streets or emergency shelters.

(remember temporary tent or armory shelters should not be counted as "shelters" – count these people as unsheltered)

Note: Not included in the figures below are persons classified by HUD as Precariously Housed:

Precariously Housed. These are people on the edge of becoming literally homeless who may be doubled up with friends or relatives or paying extremely high proportions of their resources for rent. The group is often characterized as being at imminent risk of becoming homeless.

(Even though HUD does not include this population in their count, many of our regions did a very thorough job on the count and were able to get information on this population. Those results are included at the end of the report)

State of Idaho 2010 - Region One Point-in-Time Count Chronically Homeless

Chronically homeless are defined by HUD's as:

An unaccompanied homeless individual with a disabling condition who has either been continuously homeless for a year or more OR has had at least four episodes of homelessness in the past three years. To be considered chronically homeless, persons must have been sleeping in a place not meant for human habitation (e.g. living on the streets) and/or in emergency shelter during that time.

Note: HUD's definition of chronic homelessness does not include families/households.

For the night of Wednesday, January 27th there were 644 sheltered and unsheltered homeless individuals and persons in families counted.
