### **Caring for Trees After the Storm**

Having storm damaged branches pruned out and subsequent follow up work



can significantly extend the life of trees and ensure public safety. In some cases, however, tree removal may be necessary. Tree removal requests for trees in the public right-of-way go through the city's Urban Forestry Committee, but after severe storms and depending on the extent of the damage, the Urban Forester may

Tell us a little bit about yourself. I'm 58 years old and have been a resident of Kootenai County for the last 26 years. I enjoy traveling (some fun vacations include a Mediterranean cruise to Italy from Spain, Puerto Vallarta, an Alaskan cruise, and Williamsburg, Virginia.) At home, I read and spend time with my family. I also write fiction, having published three "YA" (Young Adult") books with a fourth in the works (I've got copies if anyone is interested!). I sit on the Board of On Site for Seniors, a nonprofit medical services organization providing in-home care for seniors who cannot or who have difficulty leaving their residences (including nursing homes and assisted-living facilities) to obtain needed medical care, patient advocacy, and spiritual support. In the past, I've been active in the local Community Theater, both writing and directing plays at the Lake City Playhouse (now The Modern Theater).

What is your education and professional **background?** I received my bachelor's degree in International Relations from the University of Southern California (Go Trojans!) in 1979. I started law school at the University of Idaho in Moscow the fall after Mount St. Helens exploded in 1980, graduating in May, 1983. I spent two years as a law clerk for the Idaho Court of Appeals, then entered private practice with Quane, Smith, Howard & Hull in 1985. I joined the firm's Coeur d'Alene office in 1989. In 2011, I opened up my own firm in Coeur d'Alene, later moving the office to Post Falls. I have represented the cities of Coeur d'Alene, Spirit Lake, Ponderay, and Athol, the State of Idaho, several fire districts, and private clients. I have served on many Bar committees and received a professional service award from the Idaho State Bar. I'm licensed in Idaho and Washington, and have tried over 80 civil jury trials in state and federal courts. I've argued before the Idaho Supreme Court and the Ninth Circuit Court of Appeals.
