#### Coeur d'Alene Hires New Deputy City Administrator

The City of Coeur d'Alene has hired Sam Taylor, a native of the community, to be the next Deputy City Administrator. Taylor brings more than a decade of experience in journalism and public administration to the City, where he will be responsible for, among many things, internal and external communication, City liaison to the Arts Commission and CDA 2030, accountable for City parking issues, assisting with the supervision of departments and helping with special projects. A graduate of Coeur d'Alene High School and the University of Idaho, Taylor was the top candidate after a nationwide search for the new employee. Taylor has worked at five newspapers in Idaho and Washington before transitioning to a public service career in local government. In that capacity, the new deputy worked as both the city clerk and community information officer and assistant city administrator for Ferndale, Washington, and comes to Coeur d'Alene after working the last year as the deputy city manager for the City of Morro Bay, California. Taylor begins June 13th.

with high school students. Among the injuries were 2 fatalities, 3 critical patients, 2 non-critical patients and 1 intoxicated person. The entities try to make the mock crash scene as real as possible to show the students the perils of driving while intoxicated or texting.

## CDA Raising the Bar for Child Care Facilities

The Coeur d'Alene City Council recently adopted new regulations for licensed child care facilities. The changes, proposed by the Panhandle Health District and the Coeur d'Alene Childcare Commission, raise the standards for licensed facilities to operate in Coeur d'Alene. The new



rules reflect current health and safety data trends. Increased use of electronic nicotine delivery systems has prompted a heightened awareness of the harmful effects of nicotine. Under the newly adopted regs, child care providers must secure all nicotine devices away from children, accompanying the existing prohibition of smoking when children are present. Providers are also required to implement safe infant sleep practices, where sleeping infants are properly placed in Consumer Product Safety Approved equipment. The ordinance also includes regulation of ambient temperature inside childcare centers and homes.

## Planting for the Future: Re-Leaf CDA Plants New Street Trees

The City of Coeur d'Alene is in the midst of planting 100 new street trees within the public right-of-way areas within the city through the Re-Leaf Program. Trees are planted at no cost to the homeowner to enhance our neighborhoods and provide many street-side benefits such as mitigating storm water, reducing pollution, increasing oxygen, buffering noises and providing habitat for wildlife. Trees were provided to homeowners who are willing to provide care, including watering and protecting from mowers and trimmers. Didn't get on the list? Don't worry! Contact the Urban Forestry Division of the Coeur d'Alene Parks Department to sign up for the next spring planting, or a possible fall planting. Funds for the program come from forfeited street tree fees on building permits. To sign up for a tree, send an email to
