IDAHO REBOUNDS—Guidelines For Opening Up Idaho

<u> STAGE 1 May 1 — May 15</u>

Public/Private Gatherings: Should be avoided.

Daycares, organized youth activities and camps: May reopen **Places of worship:** Can only open if they adhere to strict physical distancing, sanitation protocol and CDC guidance.

Restaurants: Only drive thru, carry out or delivery.

Bars & Nightclubs, Indoor gyms and recreation facilities, Hair Salons and Large Venues (e.g. movie theaters and sporting venues): Remain Closed.

<u>STAGE 2</u> May 16 — May 29

Public/Private Gatherings: With less than 10 people with appropriate social distancing can occur.

Restaurants: Can open once their plans have been submitted for approval by local public health.

Indoor Gyms and Recreation Facilities: Can open if they have the ability to meet business protocols.

Hair Salons: Can open if they have the ability to meet business protocols.

Bars & Nightclubs & Large Venues (e.g. movie theaters and sporting venues): Remain Closed.

<u>STAGE 3 May 30 – June 12</u>

Public/Private Gatherings; Permissible for 10-50 people with appropriate social distancing.

Bars & Nightclubs & Large Venues (e.g. movie theaters and sporting venues): Remain Closed

A Proclamation by Governor Little clarified the open meeting laws during this state of emergency, in which no more than 10 people shall physically gather at a time, and including an option for the community to hear the meeting timely through telecommunication devices. Public comment will be taken during that section of the meeting by indicating a raised hand through the Public comments will not be Zoom meeting application. acknowledged during any other time in the meeting, unless there is a public hearing noted. Cd'A Library Returns to Curbside Service May 4

The Coeur d'Alene Public Library will resume curbside service and accepting checked out returns on Monday, May 4, Monday through Friday, 10 a.m. - 6 p.m. The building will remain closed to the public for the time being.

"This is the first phase of what we hope will lead us back to regular operations," said Library Director Bette Ammon. "A lot depends on people continuing to make an effort to slow the spread of COVID-19."

Ammon said that the library will be partially staffed Monday through Friday, 8 a.m. to 6 p.m. Curbside service will be available 10 a.m. to 6 p.m. Monday through Friday.

All programs at the library will continue to be offered online at least through May.
