#### C. Announcements

- 1. Commission Comments: Mortar on the masonry has not been cleaned off the Coeur d'Alene Ave Parking Garage and may not be done until weather permits.
- Staff Comments: Coeur d'Alene Ave. Parking Garage walk through is Thursday, November 15 at 1:30, the ribbon cutting is on Tuesday, November 20 at 11:00 AM. Meeting with Midtown stakeholders regarding parking took place on November 5. There are discussions about improvements to lighting and signage.
  A letter to the editor was written by an unhappy patron. Staff worked with the customer and issued a refund.

### D. Old Business:

- 1. Parking Lot Revenue Update: Total revenue was just over \$71,000 for September. Approximately \$182,000 was deposited into the parking fund for the end of the fiscal year. October of 2018 income was \$37,442. It has increased about \$10,000 from 2017.
- 2. Change of Parking Lot Rates for all Surface Lots. MOTION: Motion by Commissioner Chapkis, seconded by Commissioner Melbourn, to recommend to council the change of parking rates for all surface parking lots and mooring as follows: ICO1 single stall parking \$1.00 per hour and oversized parking \$2.00 per hour, ICO2 \$3.00 per hour May 1 September 30 and \$2.00 per hour October 1 April 30 with no overnight or RV parking, ICO3 \$2.00 per hour with no overnight or RV parking, ICO4 \$1.00 per hour with no overnight or RV parking, employee parking passes for McEuen \$20 per month and \$25 per month starting May 1, employee parking passes for Coeur d'Alene Avenue Garage \$15 per month plus transaction fees, \$10 event parking for Car d'Lane and Street Fair, \$20 event parking for the 4<sup>th</sup> of July and tiered event parking (ICO2 \$20, ICO1 & ICO3 \$15, ICO4 & CDA AVE Garage \$10) for Half Ironman and Lighting Ceremony Parade, mooring docks \$2.00 per hour and \$25 for overnight mooring (11:00 pm 8:00 am)
