**Staff Comments:** Andrea with Diamond questioned the six-month minimum lease, wondering if this was set or could be changed. Commissioner Brad Jordan motioned make a recommendation to add discussion of the Secured Garage to next month's agenda. Seconded by Commissioner Melbourn. The City working with Diamond is working to sell the residential passes to utilize the downtown parking areas. This information is on The City website as well as Diamond Parking's website.

#### Parking Lot Revenue Update:

December 2019 total revenue was \$58,510 which was an increase from 2018 by 9,422.

#### **NEW BUSINESS:**

**2020 Goals:** Discussed of improvement of signage throughout downtown to direct the public to the CDA Ave. Garage. Diamond Parking is working on getting the LPR (License Plate Recognition) software running for this year. The Commission discussed formation of a parking sub-committee specially to work toward bettering the signage for parking.

**Discussion:** The commission discussed having an event price in the CDA Ave. Garage to be added to avoid leaving the gates open losing revenue. Troy Tymesen brought awareness to the previously motioned abolishment of all event pricing aside from the July 4<sup>th</sup>. This will be further discussed. Brenna Waterbury recommended amendment to the 300 feet rule being added signage.
