When requesting estimated fees for residential construction, the fees are determined by each department based on the project. Residential construction fees include much more than just building department permit fee. The information provided below is an attempt to provide you with an understanding of the estimated costs associated with residential construction fees. Fees are determined by valuation¹ and location².
