*INSPECTIONS* – Flashing and/or house wrap is required to be inspected prior to covering. A minimum rating for U value on doors and windows is .32. To call for an inspection please call the inspection line at 769-2391. The Hillside Subdivision Ordinance may require planning department review prior to issuance of a permit.

- *EGRESS WINDOWS* – Shall have a window sill height of not more than 44 inches above the floor. In the open position, the minimum opening height shall be 24 inches and the minimum width shall be 20 inches. Height times width shall not be less than 5.7 sq. ft. as the minimum net clear area. **EXCEPTION:** Grade floor openings may have a minimum net clear opening of 5 sq. ft.
