### **DECISION POINT:**

City Council is requested to approve a one-year extension to the current Police Association Agreement which establishes already agreed upon compensation and benefits.

### **HISTORY:**

The current three-year term for the Police Association Agreement commenced on October 1, 2018, and expires September 30, 2021. The extension to the Agreement shall be applicable to all Police Association represented classifications for an extension term commencing October 1, 2021, and ending September 30, 2022.

### **FINANCIAL:**

There are no changes from the current POA Agreement. However, extending the compensation benefits for the POA's current staffing, will have the following costs, which are captured in the proposed 2021-2022 budget.

## EXTENSION AGREEMENT

THIS AGREEMENT is made and dated this \_\_\_\_\_ day of \_\_\_\_\_, 2021, by and between the City of Coeur d'Alene, Kootenai County, Idaho, a municipal corporation organized and existing under the laws of the state of Idaho, hereinafter referred to as the "City," and the Coeur d'Alene Police Officer Association, an organization duly organized and existing under the laws of the state of Idaho, hereinafter referred to as the "Association."

### W I T N E S S E T H:

WHEREAS, the City and the Association entered into an Agreement governing labor relations on August 21, 2018, hereinafter referred to as the "Agreement;" and

WHEREAS, the Agreement expires on September 30, 2021; and

WHEREAS, Article 34 of the Agreement provides that "[i]f a new agreement has not been reached between the CITY and the ASSOCIATION upon expiration of this agreement, this agreement will remain in effect and unchanged until a new agreement is reached"; and

WHEREAS, the parties to the Agreement have determined that it is in their mutual best interest to formally extend the Agreement for one year without prejudice or penalty to either party.

### NOW, THEREFORE,

1. Article 34 of the Agreement is hereby amended to read as follows:

SECTION 1. This Agreement shall be effective as of the first day of October, 2018, and shall remain in full force and effect until the 30th day of September, 2022. If a new agreement has not been reached between the CITY and the ASSOCIATION upon expiration of this agreement, this agreement will remain in effect and unchanged until a new agreement is reached.

2. In all other respects, the terms and conditions of the Agreement shall remain unchanged.

IN WITNESS WHEREOF, the Mayor and City Clerk of the city of Coeur d'Alene have executed this Agreement on behalf of said City, the City Clerk has affixed the seal of said City hereto, and the Association has caused the same to be signed by its President, attested by its Secretary, the day and year first above written.

**SUBJECT:**    **SURPLUS OF POLICE VEHICLES**

---

**DECISION POINT:** Should Council authorize the Police Department to surplus one 2004 Chevrolet Impala, two 2006 Chevrolet Impalas, and one 2013 Chevrolet Tahoe, and sell them at auction?

**HISTORY:** The 2004 Impala is a previously retired patrol vehicle that was converted into a spare K9 vehicle several years back. This vehicle is no longer needed for this function and is equipped with extremely outdated and expired police equipment.

The two 2006 Impalas register 106,000 and 120,000 odometer miles. Both vehicles served most of their lives in patrol and were reassigned to Volunteer and Code Enforcement around 2016. Both vehicles have lists of fluid leaks, ABS brake issues, and one has a failed transmission.

The 2013 Chevrolet Tahoe registers 115,000 odometer miles. This vehicle has been in patrol its entire life. There are many mechanical issues with this vehicle including burning 1 quart of engine oil every 400 to 500 miles. The appearance and mileage of this vehicle do not warrant rebuilding the engine to solve the oil consumption issue.

**FINANCIAL ANALYSIS:** There is no financial impact to the City, other than minimal costs of transportation to Post Falls for auction. The auctioneer receives a 20% commission for sales between \$500 and \$749.99, 15% commission for sales from \$750 to \$999.00 and 10% for sales over \$1000. These fees are deducted from the item auction proceeds and a check provided to the owner for the balance. Proceeds from the sale of these vehicles will be returned to the General Fund.

**DECISION POINT:** Council should authorize the declaration of one 2004 Chevrolet Impala, two 2006 Chevrolet Impalas and one 2013 Chevrolet Tahoe assigned to the Police Department as surplus and the sale of these vehicles at auction.

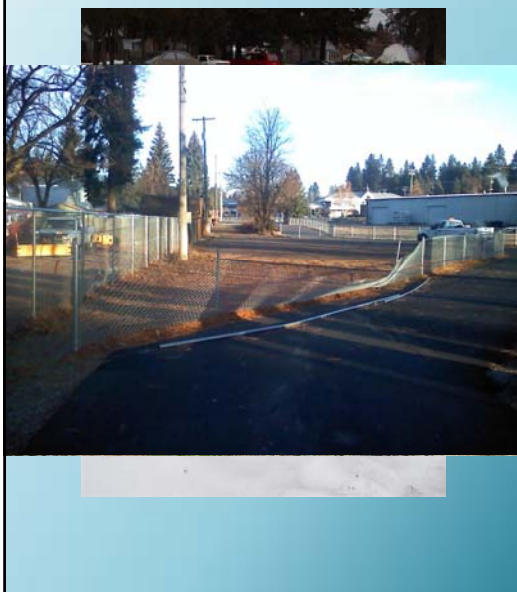

### NOT SO FUN STUFF



**Parks and Trails** – We maintain 587 acres that include 32 parks, 393 acres of Natural Open Space, 50 miles of pedestrian and bike paths and 9 miles of hiking trails. Each season we have an average of 125,500 people post reservations for 7054 hours of use. We also maintain another 52 acres of non-park areas, including beautifications areas and city building landscaping.

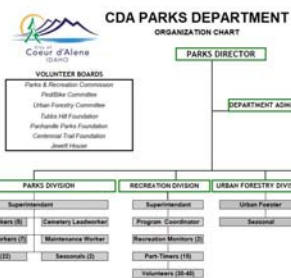
**Recreation** – We offer 24 regular scheduled programs for 6,000 participants. We serve another 4,000 participants for special events, tournaments and the swim program.

**Cemetery** – We provide maintenance for Forest Cemetery, which is 22 acres, and Riverview Cemetery, which is 7.5 acres. On average we perform 130 burials. Currently we have 17,440 interments with 3,483 lots.

**Urban Forestry** – We manage over 22,000 street trees and over 4,000 park trees, along with thousands more in our Natural Open Spaces.

**Building** – We maintain 40 City-owned building, totaling 214,766 square feet.

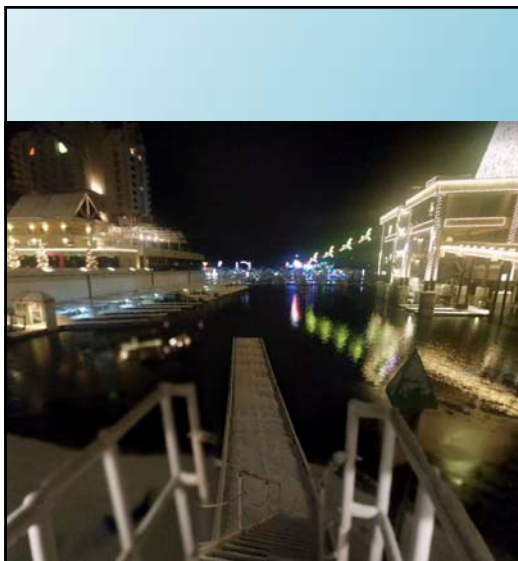
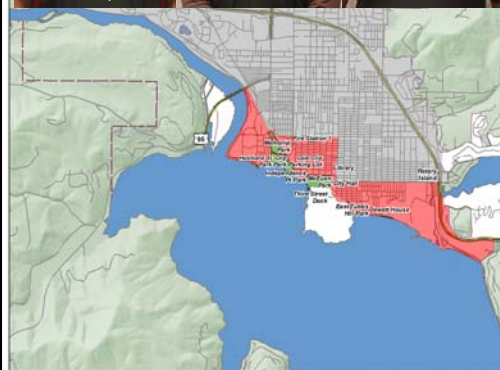

**1<sup>st</sup> Street Dock** – Est. 1986. These mooring docks are located west of the resort. The dock supports 6 boats and can be used for up to 72 hours.



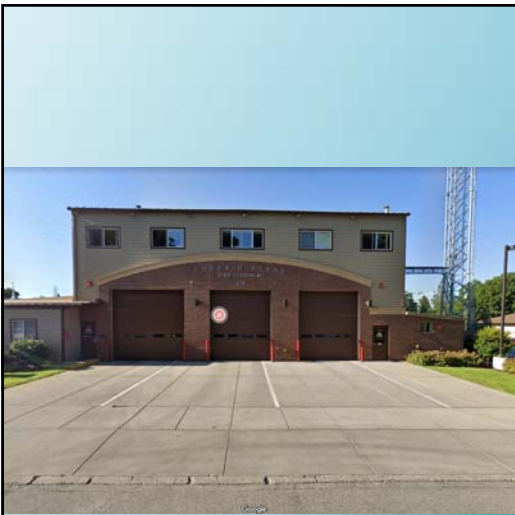
**City Park and Beach** – Est. 1904. This 15.5 Acre park was Cd'A first park and has a swim beach, basketball courts, picnic shelter, grills, drinking fountains, sand volleyball courts, restrooms, picnic tables throughout the park, and off-street parking.



**City Park Parking Lot** – This pay lot includes 116 parking stalls for shared use with the museum of North Idaho



**Fort Sherman** – Est. 1997. This 14,000 square foot wooden playground was funded by the Panhandle Kiwanis Club and was built in 5 days by over 2,000 volunteers.

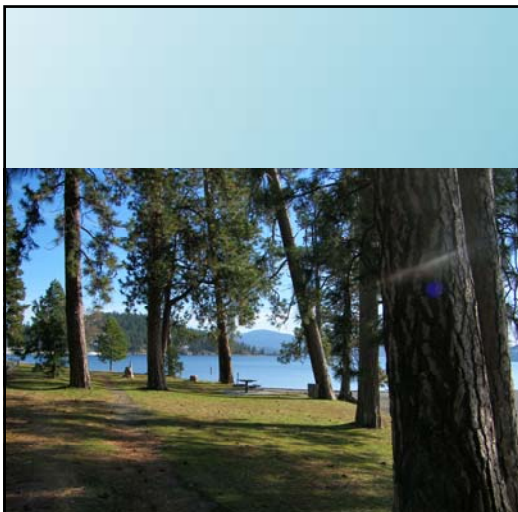


**Fire Station 1** – Est. 1972. This 6,000 square foot building is the location of one of Coeur d'Alene's four fire stations. The department maintains the grounds around the station as well as maintenance of the building itself.



**Fire Administration** Est. 1972. This 5,400 square foot building is located directly adjacent to Fire Station 1. The department maintains the grounds around the station as well as maintenance of the building itself.





**Hubbard Street Park** – Est. 1990. This half-acre beach park is located to the west of Coeur d'Alene City Park and has shade trees, picnic tables and beach access.



**Independence Point Park** – Est. 1976. This 4 acre park is located near the Coeur d'Alene Resort and the downtown area, this facility connects to City Park and has a beach, swim area, benches and water features. Tour boats, seaplanes, parasailing and other aquatic equipment is available.



**Commercial Dock** – Est. 1976. This 7,680 square foot dock offers kayak and watersport rentals, parasailing, and seaplanes rides.



**Memorial Park** – Est. 1922. The 12 acre park was redeveloped in 2018 and is part of the greater City Park Complex. Parks amenities include a softball field with historic grandstands, a carousel, a large shared-use parking lot, a playground, pickle ball courts, a Futsal court, a restroom/gazebo building and an extensive skate park.





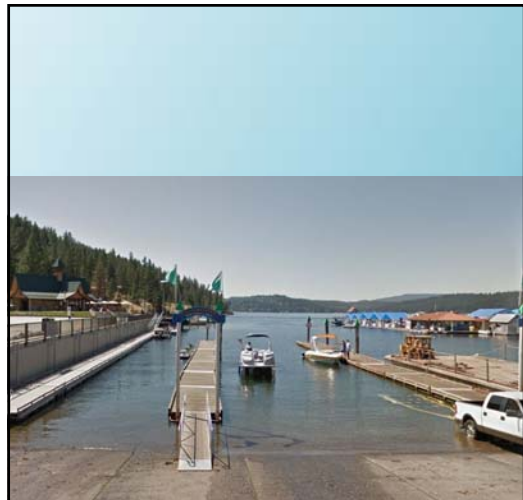
**Museum of North Idaho** – Est. 1979. This 11,000 sq foot building hosts the museum of North Idaho. The Parks Department maintains the grounds around the museum.



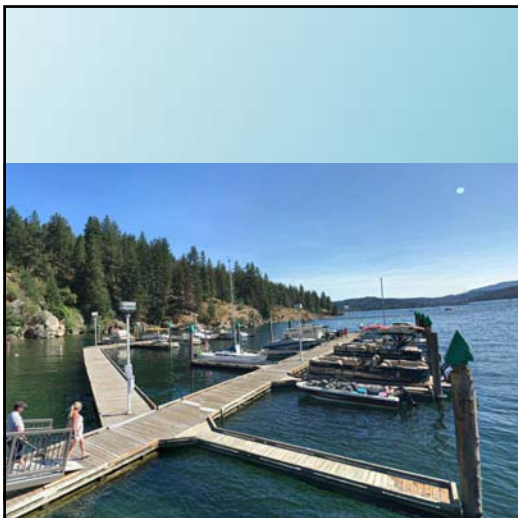
**NW BLVD South Islands** – Beautification area located on Park Drive and Fort Grounds Drive near City Park.



**Skate/BMX Park** – Est. 1995. This 1,400 sq foot skatepark was constructed in 2018 after the old skatepark was removed during the reconstruction of Memorial Park.



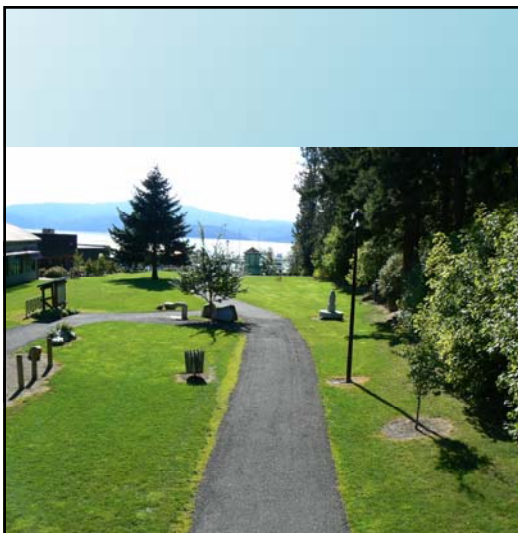
**3<sup>rd</sup> Street Dock** – Est. 1956. These docks and ramps are located east of the resort on 3<sup>rd</sup> street. There five pay launches with a 20 minute time limit and boat parking available in the McEuen lot.



**Mooring Docks** – Est. 1956 and rebuilt in 2002. These docks will host 36 boats, available at an hourly rate or an overnight rate. Visitors can rent the slips for up to 72 hours.



**City Hall Grounds** – Est. 1970's. This 13,600 sq foot building houses City Hall Administration, the Building Department, Human Resources, Legal, Municipal Services, Parks and Recreation, and the Planning Department.



**East Tubbs Hill Park** – Est. 1990. This 2 acre park offers open space, restrooms, a parking lot trail head, a Tubbs Hill map interpretive sign, and trail access to Tubbs Hill.



**Jewett House** – Est. 1917. This senior center was gifted to the City in 1978 at which time it became a social and recreation center for seniors. The Jewett House also hosts weddings. The department is responsible for landscaping and building maintenance, as well as programming events.



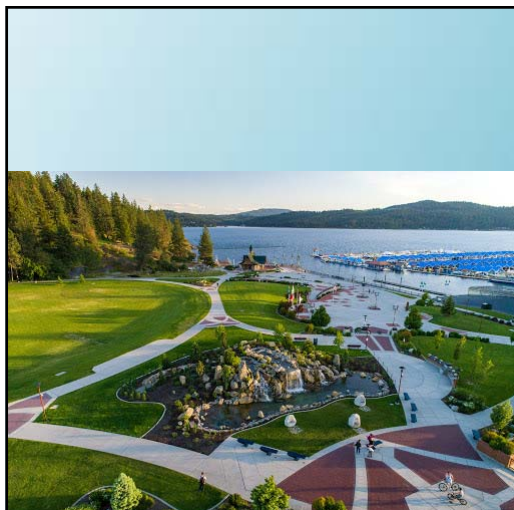
**White House – North Idaho Museum – Est. 2020.** This 6,000 historic house was built in 1904 at 8<sup>th</sup> and Sherman. It was moved to the McEuen Campus in 2020 and is the future home of the North Idaho Museum.



**Library – Est. 2007.** This 24,000 sq foot building is located near City Hall. The department maintains the grounds and the building.

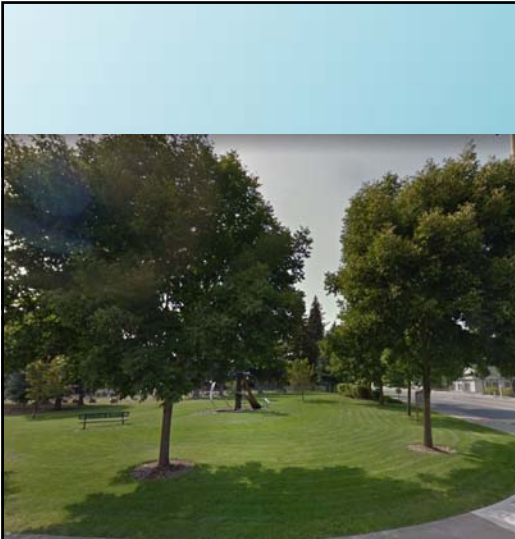


**McEuen Park – Est. 1956.** This 22 acre park has a playground, a splash pad, tennis/pickle ball court, basketball court, off-leash dog park, a pavilion, the concession building, a grand plaza, Veterans Memorial, and a 4-acre grassy area with room to hold events for up to 5,000 people. This park also hosts a boat launch, a trail network, mooring facilities and a trail head for Tubbs Hill.



**K27 Memorial – Est. 2016.** This water feature was built as a memorial to Sgt Greg Moore. It features 3 waterfalls, a pond and adjustable lighting.

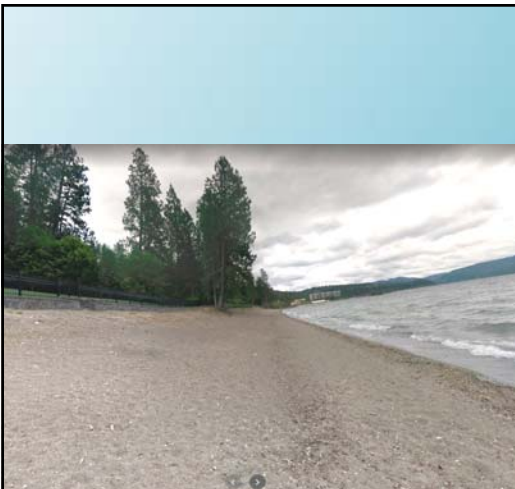




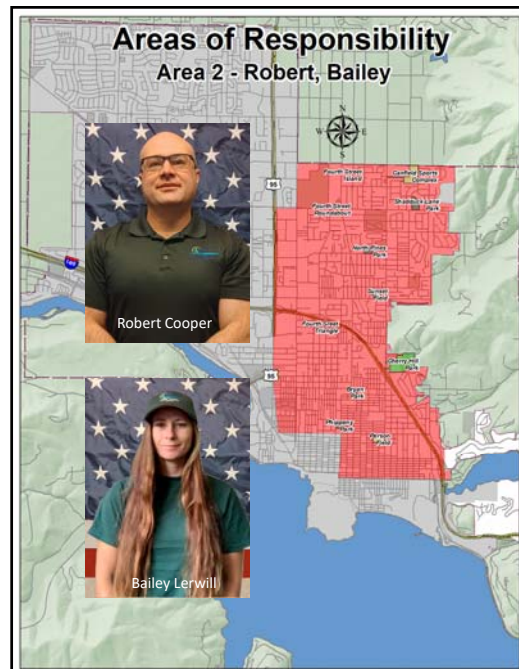
**Rotary Island** – This beautification area is  $\frac{3}{4}$ 's of an acre and is located on Sherman and Cd'A Lake Drive.



**12<sup>th</sup> Street Beach Park** - Est. 1900's. These public beaches are located east of Tubbs Hill and are separated from each other by 1,000 feet of privately owned water front. Combined they total nearly 1.25 acres and 1,000 feet of public beach access.



**Sanders Beach Park** - Est. 1900's. These public beaches are located east of Tubbs Hill and are separated from each other by 1,000 feet of privately owned water front. Combined they total nearly 1.25 acres and 1,000 feet of public beach access.

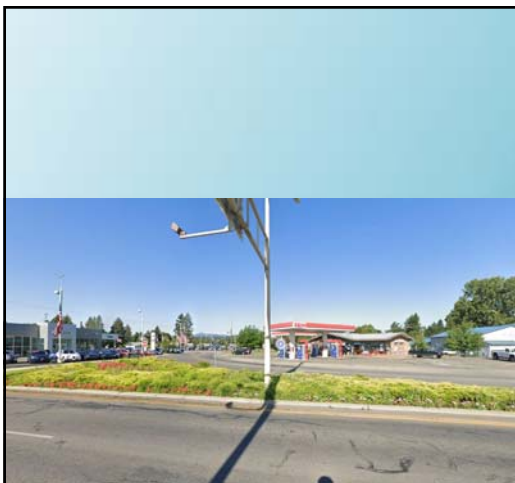




**4<sup>th</sup> Street Islands** – This 3,000 sq foot beautification area is located near Cd'A High School and is maintained by the department



**4<sup>th</sup> St Roundabout** – This 10,000 sq foot beautification area is located in and around the roundabout on 4<sup>th</sup> and Kathleen and is maintained by the department.



**4<sup>th</sup> St Triangle** – This 3,500 beautification area is located on 4<sup>th</sup> Street near Dave Smith Motors and is maintained by the department.



**Bryan Park** – Est. 1957. This 2.5 acre park offers a children's baseball field, play equipment, and a basketball court. On street parking only.



**Canfield Sports Complex** – Est. 2003. This 16 acre sports complex has four Little League fields, a tournament-size soccer field, drinking fountains, off-street parking, and restroom shelter.



**Cherry Hill Park** – Est. 2005. This 35 acre park has an 18-hole disc golf course, an off-leash dog park, basketball, a BMX track, tennis and pickle ball courts, sledding, off street parking, restrooms, the 9/11 Memorial playground, and Fallen Heroes Plaza.



**Cherry Hill BMX Park** – This race track is a mix of asphalt and dirt and is primarily used for BMX races.



**Fallen Heroes Plaza** - The Fallen Heroes Plaza was dedicated on September 11, 2009, and is dedicated to fallen firefighters and police officers. The 9-11 Memorial Playground and Plaza were supported with donations from many local organizations.





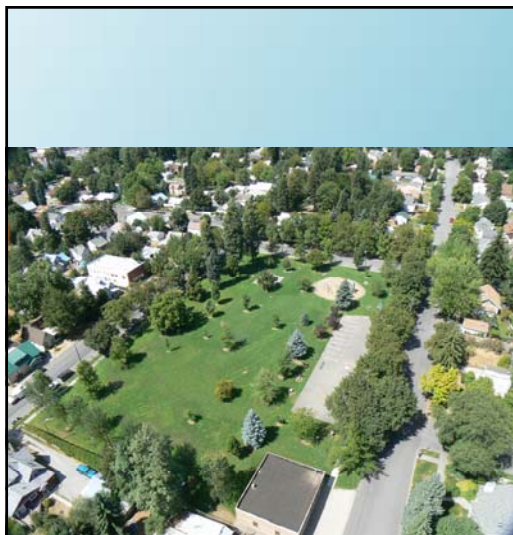
**Fire Station 3** – This 10,000 sq foot building is home to one of Cd'A's four fire stations. The building and the grounds are maintained by the department.



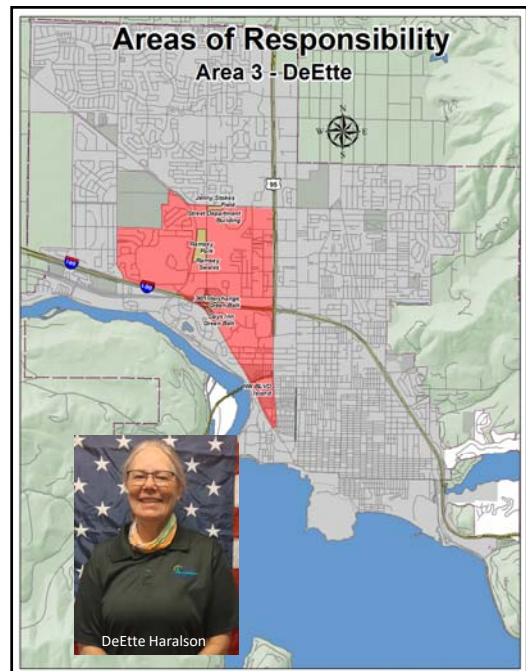
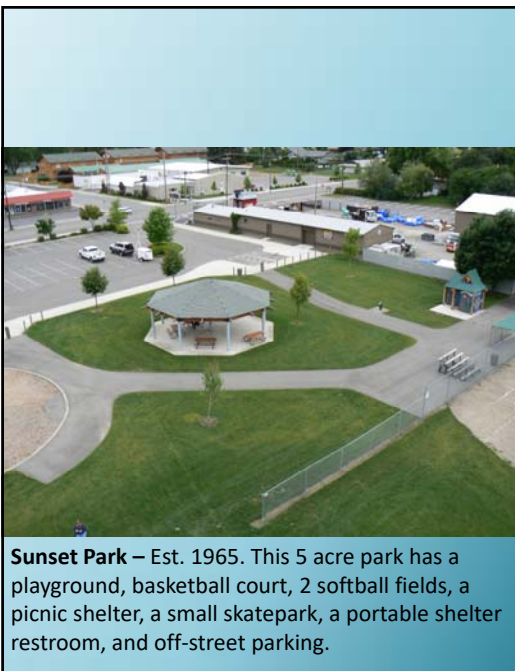
**North Pines Park** – Est. 2007. This 3.5 acre park offers a playground, basketball, grass volleyball courts, a picnic shelter, a drinking fountain and restrooms.



**Person Field** – Est. 1956. The 7.5 acre park is a multi-purpose playfield with a small neighborhood playground. Some uses include junior tackle football, softball, and track.



**Phippeny Park** – Est. 1989. This 2.5 acre park has a playground, basketball, off-street parking, a tree identification area, a picnic shelter and a portable shelter restroom.







**Northwest Blvd North Islands** – These beautification islands on Northwest Blvd total 1 acre and are maintained by the department.



**Fire Station 2** – This 12,000 sq foot building is home to one of Cd'A's four fire stations. It is located on Ramsey Rd and Kathleen avenue and is maintained by the department.



**Police Station** – This 25,000 sq foot building houses the City's Police Department and is maintained by the department.



**Jenny Stokes Field** – Est. 1996. This 3 acre sports field is primarily used for league soccer games and practice.



**Street Department** – This 17,500 building is home of the Street Department and the ground and building are maintained by the department.



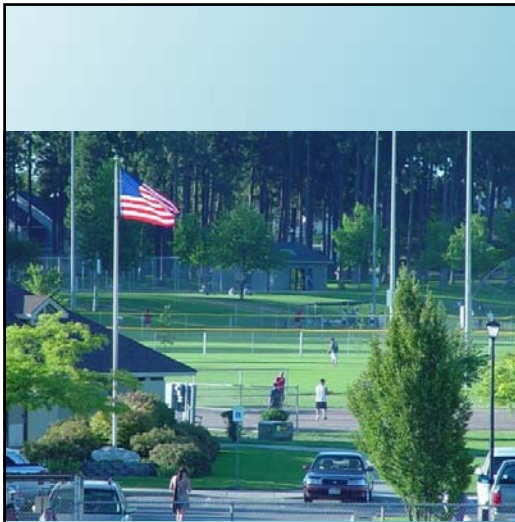
**I-90 Interchange** – This 12 acre beautification area is located on the NW Blvd/I-90 off and on ramps and is maintained by the department.



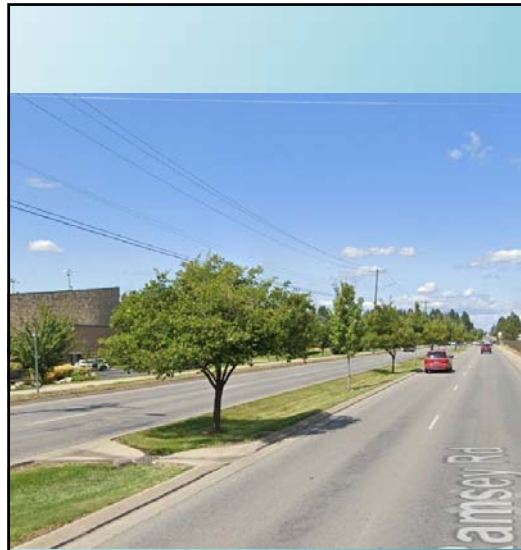
**Days Inn** – This half acre beautification area is located on NW Blvd and is maintained by the department.



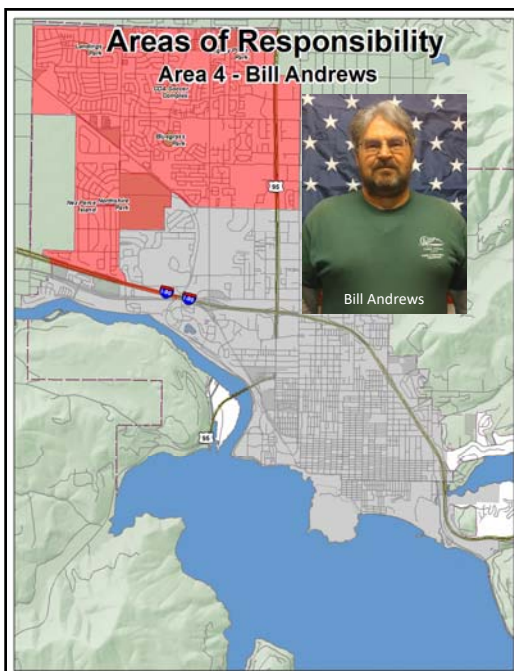
**Coeur d'Alene Rock** – This monument sign is located on NW Blvd and welcomes visitors to Coeur d'Alene. The surrounding landscaping is maintained by the department.



**Ramsey Park** – Est. 1993. This 30 acre park offers a picnic shelter, 5 softball diamonds, Thorco hardball field, tennis courts, volleyball, basketball, children's play equipment, restrooms, and access to the Prairie Trail.



**Ramsey Swales South** – These islands are located on Ramsey Road south of Kathleen Ave. and total  $\frac{3}{4}$ 's of an acre in size. They are maintained by the department.

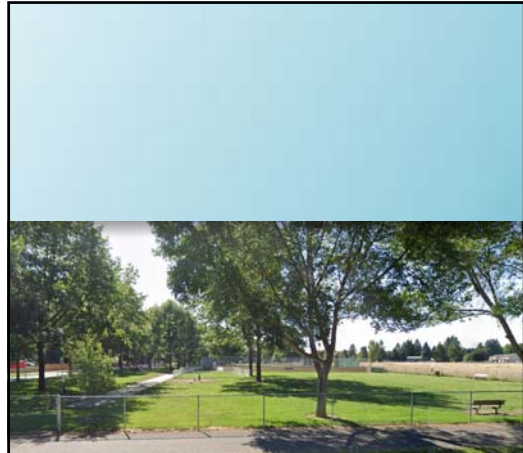


**Bluegrass Park** – Est. 1998. This 11.5 acre park has a playground, a splash pad, basketball, volleyball, tetherball, open space, a picnic shelter with grill, disc golf, paved bicycle trails, off-street parking and restrooms.





**Cd'A Soccer Complex** – Est. 2002. This 9.7 acre sports complex offers 3 full-sized soccer fields, on-street parking, lighting, portable shelter restrooms and a drinking fountain.



**Central Bark Dog Park** – Est. 2010. This 1 acre dog park is located in Northshire Park and is Cd'A's first dog park. It was relocated to the east side of the park in 2019.



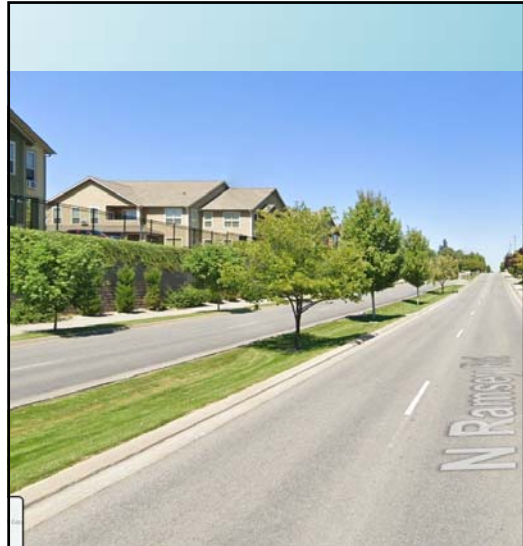
**Fire Station 4** - This 9,000 sq foot building is home to one of Cd'A's four fire stations. It is located on Atlas Road and is maintained by the department.



**Landings Parks** – Est. 2009. This 11 acre park has a playground, a toddler playground, a splash pad, basketball, volleyball, horseshoes, tennis courts, open space, two picnic shelters, paved bicycle trails, off-street parking and restrooms.



**Legacy Place Park** – Est. 2008. This 1 acre pocket park offers open space for play or relaxation, and two picnic tables. This park will be expanded when the land to the north gets developed.



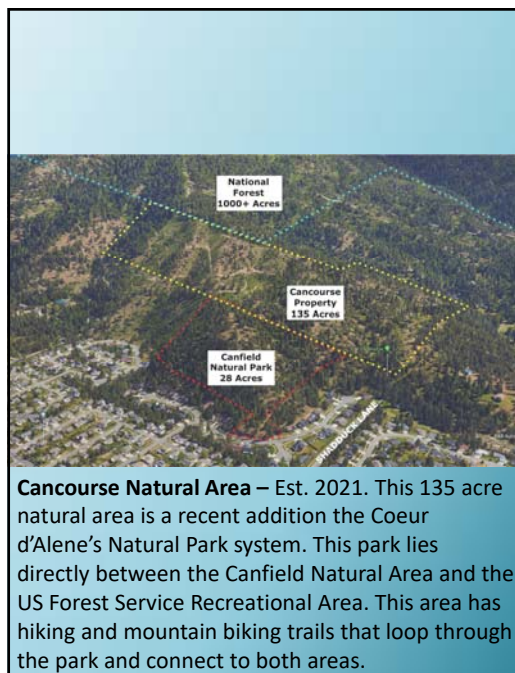
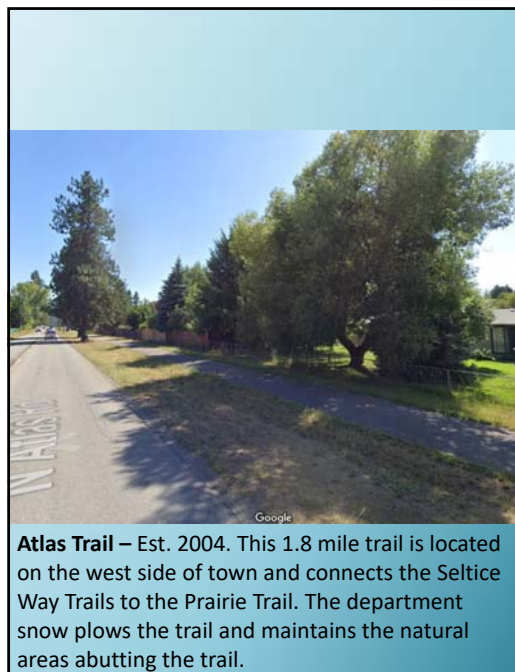
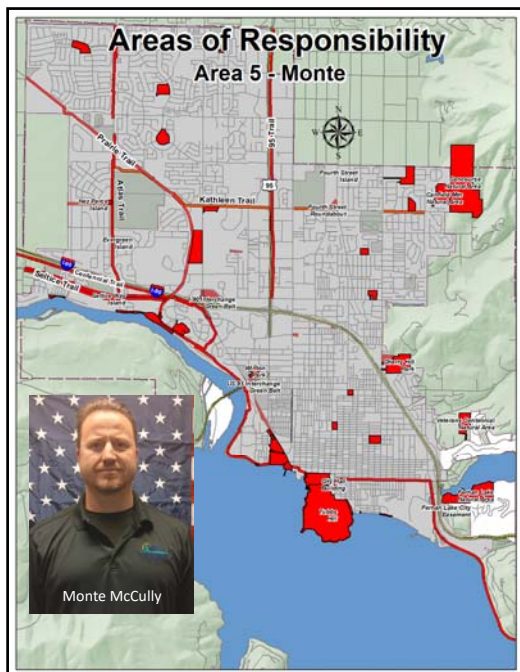
**North Ramsey Swales** – These islands are located on Ramsey Road north of Kathleen Ave. and total  $\frac{3}{4}$ 's of an acre in size. They are maintained by the department.



**Northshire Park** – Est. 1987. This 3.4 acre park offers several outdoor leisure opportunities, including a picnic area, an off-leash dog park, tennis courts, a playground, basketball, volleyball, horseshoes, and restrooms.



**Sunshine Meadows Park** – Est. 2008. This 3 acre park offers a playground, basketball, volleyball, tether ball, horseshoes, open space, a picnic shelter, a paved bicycle trail, and restrooms.







**Centennial Trail** – Completed 1997. The City of Cd'A is responsible for 9.5 miles of this 23 mile trail that runs from the west at Atlas road to the east at Silver Beach. The department snow plows the trail and maintains the natural areas abutting the trail.



**Evergreen Islands** – This 1/3 acre natural area is a island on Evergreen Way and Atlas road and is near the Atlas Trail. The department maintains the natural area in the island.



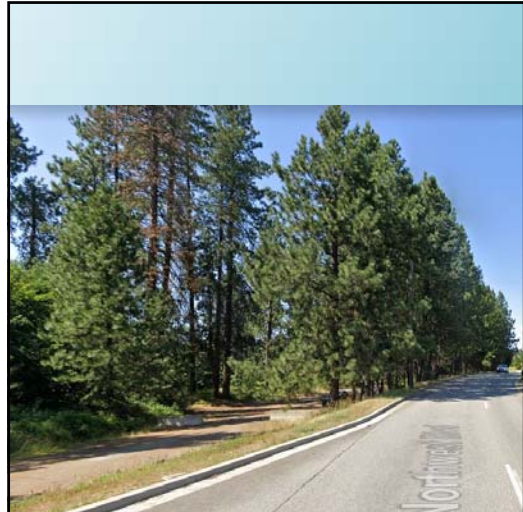
**Nez Perce Islands** – This 1.6 acre natural area are a series of islands on Nez Perce Drive off Atlas road and is near the Atlas Trail. The department maintains the natural areas on these islands.



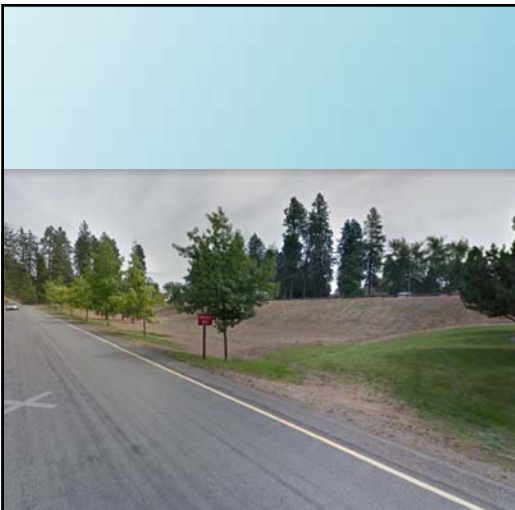
**4<sup>th</sup> St Well Site** – This 6.4 acre natural area is located at the Water Department well site on 4<sup>th</sup> St and Margaret Ave. The department maintains the natural area at this well site.



**Cherry Hill Natural Area** – Est. 2005. This 22 acre natural area is 2 separate areas that are part of the 35 acre Cherry Hill Park and has a 18 hole disc golf course. These natural areas are maintained by the department.



**NW Blvd.** – These natural areas are located in the Northwest Blvd right-of-way and in the landscape on the 95/NW Blvd ramp and are 5 acres in total size. These natural areas are maintained by the department.

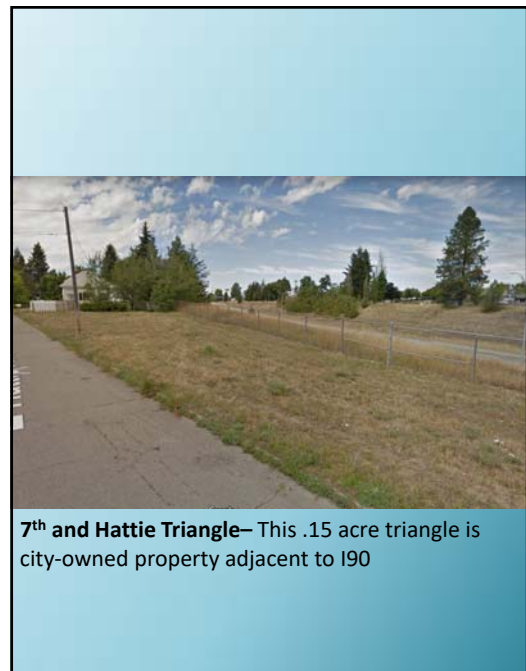
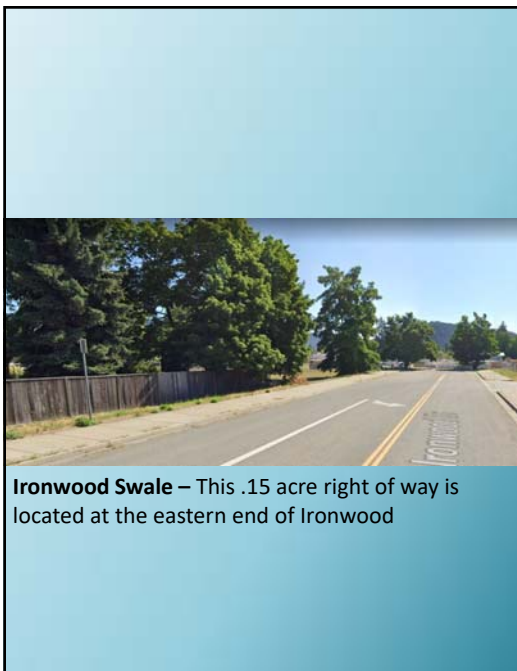
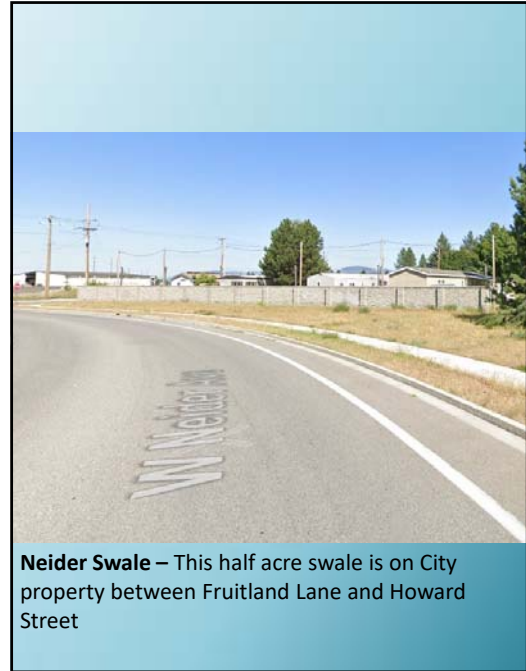


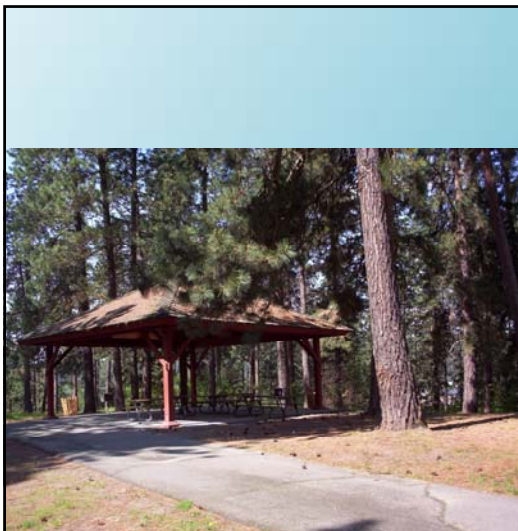
**HWY 95 Bowl** – This swale is adjacent to a beautification area the department maintains. The property belongs to ITD and is one of the gateways to the city.



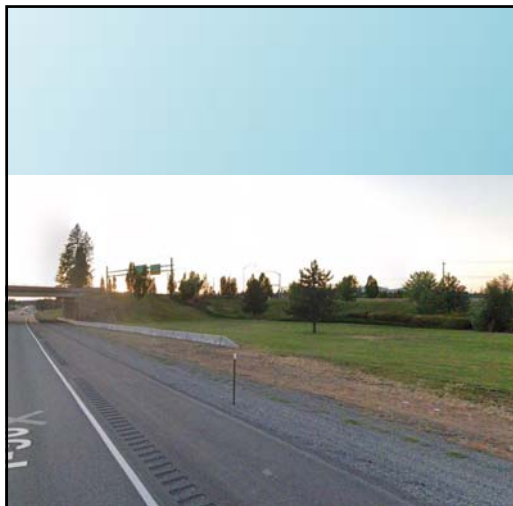
**Lee Court Swale** – This 1.85 acre parcel is between I90 and the Cracker Barrel restaurant.







**Winton Natural Area** – Est. 1981. This 3 acre natural area is part of the 6.5 acre Winton Park and has a gazebo, restroom, trail and benches. This natural area is maintained by the department.



**I-90 Natural Area** – This 2 acre natural area is adjacent to the 12 acre beautification area that is located on the NW Blvd/I-90 off and on ramps and is maintained by the department.



**Fernan Lake Natural Area** – Est. 2009. This 51 acre natural area is located on the wooded hillside on the south side of Fernan lake. There are currently 1.5 miles of hiking trails in 3 loops. The 4<sup>th</sup> and final loop is under construction and will add an additional 1.5 miles of trail. The department maintains the trails, forest canopy and natural area in this park.



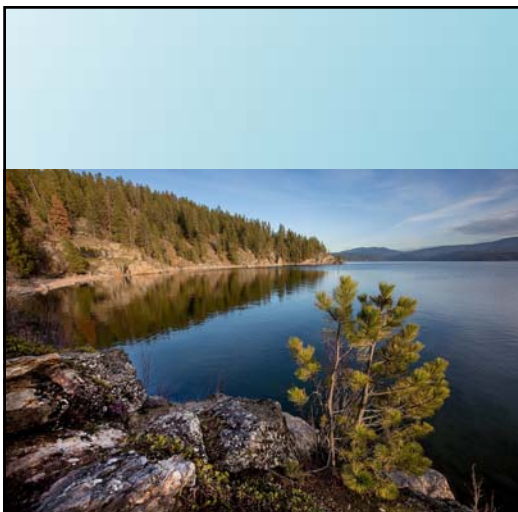
**Kathleen Trail** – Est. 2000. This 2.5 mile trail is located on the north side of town from the Atlas Trail on the west to Shadduck Lane Park on the east side of town. There are gaps in the trail that have bike lanes or shared lanes. The department snow plows the trail and maintains the natural areas abutting the trail along 1 mile of that length.



**Prairie Trail** – Est. 2008. This 3.4 mile trail runs from Riverstone Park to Huetter Ave. on the Northwest side of town. The department snow plows the trail and maintains the natural areas abutting the trail. This trail will eventually extend to Hwy 41.



**Seltice Trails** – Est. 2019. This 4 mile trail system runs from The Centennial/Prairie Trail intersection west to Huetter Ave. and back on the other side of Seltice Way. The department snow plows the trail and maintains the natural areas abutting the trail, as well as the natural areas in the center islands and the roundabouts.



**Tubbs Hill Natural Area** – Est. 1936. This 160 acre natural area is located downtown, adjacent to McEuen Park and has 5.25 miles of hiking trails. The department maintains the trails, forest canopy and natural area in this park.

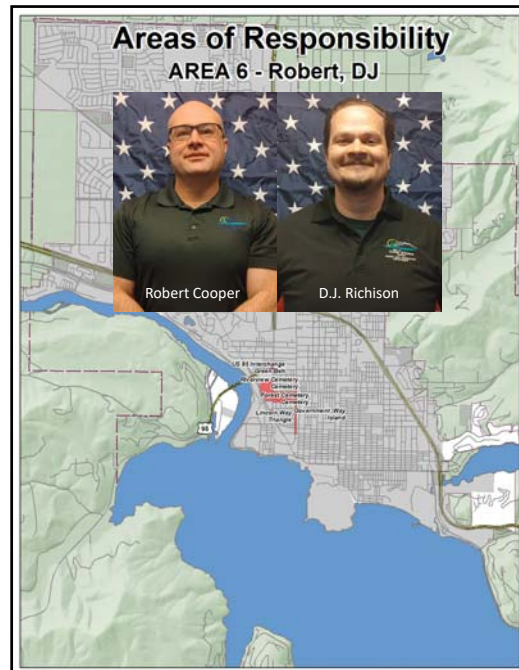


**Veterans Centennial Natural Area** – Est. 1990. This 16 acre natural open space has an open field on the south end of the park and a heavily wooded area in the north end of the park. Future plans could include an Arboretum and a hiking trail. The department maintains the natural area at this site.

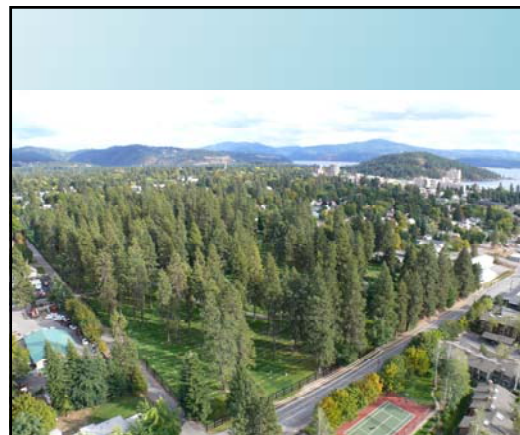




**95 Trail** – Est. 1980. This 3 mile trail was the first shared-use path in Idaho and was owned and maintained by ITD until 2021. They repaved the trail and gave maintenance responsibilities to the city. The department snow plows the trail and maintains the natural areas abutting the trail.



**C St Shop and Yard** – The 40,000 sq foot parks department shop and yard is the hub for all the vehicles, equipment and offices for the department field work. It is maintained by the department.



**Forest Cemetery** – Est. 1878. This 21.2 acre cemetery was constructed along with Fort Sherman when Coeur d'Alene was first settled by the army. In 1905, the City of Coeur d'Alene took over ownership and maintenance of this cemetery. The department is responsible for burials, turf maintenance, and maintaining the health of the forest canopy.



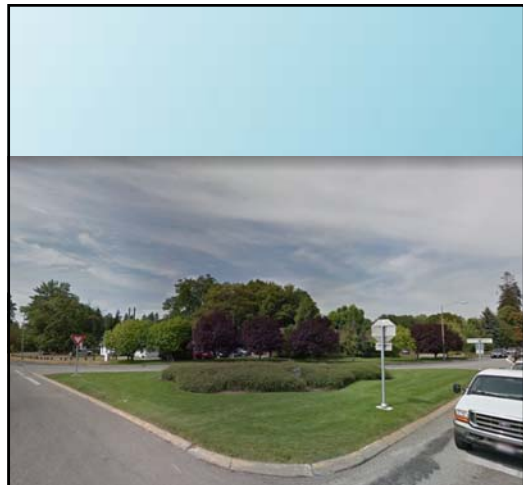
**Government Way Islands** – These islands are located on Government, starting south of Harrison and continuing to Garden Ave. The department is responsible for cleaning, mowing and maintaining the health of the street trees in the islands.



**Lincoln Way Triangle** – This 1/3 acre beautification area has turf grass and a short connector trail connecting Lincoln Way with Northwest Blvd. The department snow plows, and mows this area.



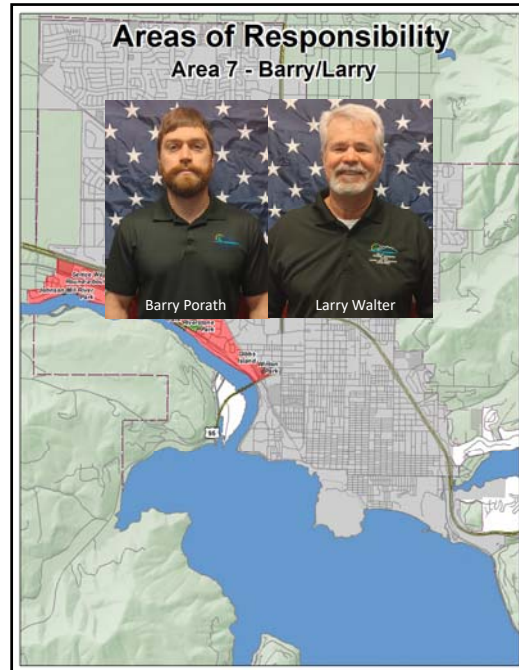
**Riverview Cemetery** – Est. 1968. This 7.3 acre cemetery was acquired by the city to help alleviate the demand on Forest Cemetery. The cemetery is located adjacent to Forest Cemetery on Lincoln Way. The department is responsible for burials, turf maintenance, and maintaining the health of the forest canopy.



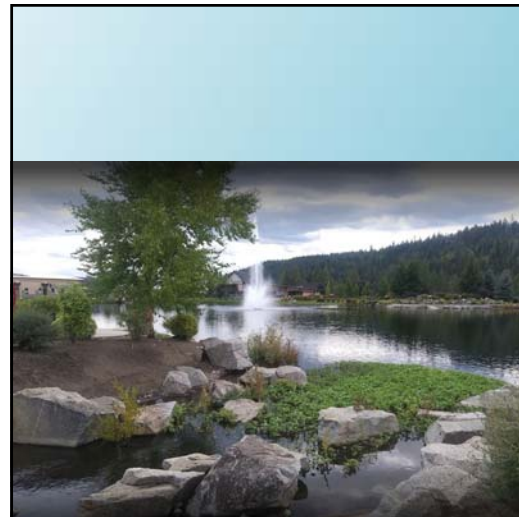
**US 95 / Walnut Island** – This 5,000 sq foot beautification area is located on Hwy 95 and Lincoln Ave. It is an island that separates lanes of traffic on HWY 95. The department is responsible for mowing the turf grass and maintain the health of the trees in this island.



**US 95 Landscaping** – This 3.3 acre beautification area is located on the on and off ramps for HWY 95 over Northwest Blvd and is landscaped with turf grass, shrub beds and trees. There is a multi-use path bisecting the area. The department snow plows the trail and maintains the landscaping in this area.



**Atlas Mill Park** – Est. 2020. This 12.5 acre park is located on the Spokane River near Riverstone park and includes 4,000 linear feet of public waterfront, as well as, an ADA accessible water dog park and ADA accessible swim area, ADA accessible picnic area, and ADA accessible kayak launch, a playground, restroom facility and picnic shelter, off-street parking, and access to the Centennial Trail.



**Riverstone Park** – Est. 2007. This 6 acre park has a picnic shelter with BBQ grills, other open space picnic areas, an amphitheater, benches, pedestrian/bicycle paths, restrooms, a playground, a small dog park, and off-street parking.





**Riverstone Dog Park** – Est. 2015. This ½ acre dog park is located just off the Centennial Trail and has doggie drinking fountains, benches and waste receptacles.



**Seltice Corridor** – Est. 2019. These beautification areas located in the roundabouts on Seltice way total ½ acre and are maintained by the department.



**Seltice Trailhead** - Est. 1989. This beautification area is located at the intersection of Seltice way and Northwest Blvd. It totals 1.8 acres and has 2 art pieces. The Sails and the Arachnid bench.



**Mill River Park** – Est. 2006. This 1.6 acre park is located on the southwest corner of town and offers a swim beach, picnic shelter, portable restrooms during season, an observation area, a day use boat dock, a fishing area, picnic tables, and limited off-street parking.

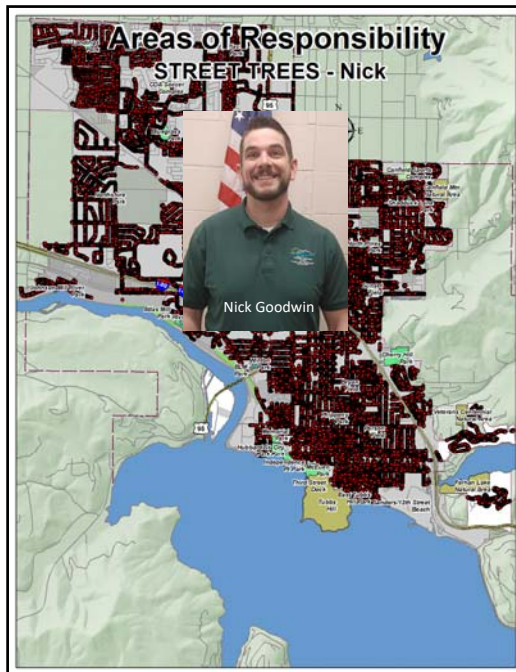

Assists city staff and the public regarding tree information including all commercial permit applications and plan reviews including subdivision plan review.

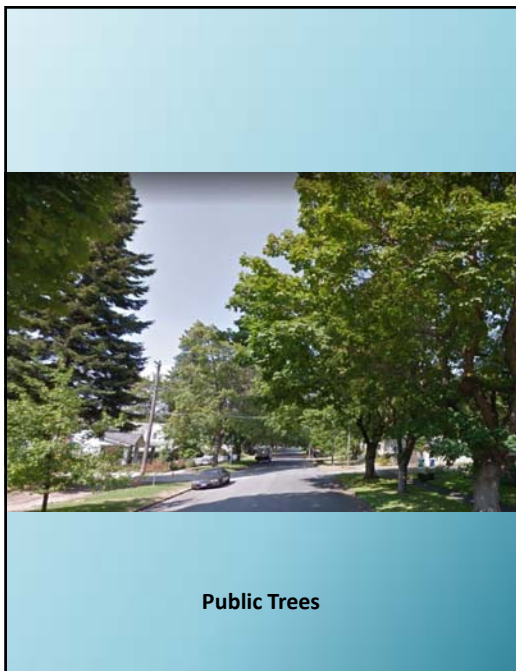
Maintains city urban forestry ordinances and regulations.

Coordinates public tree planting and maintenance as well as manages the cost share maintenance program for residential single family homeowners.

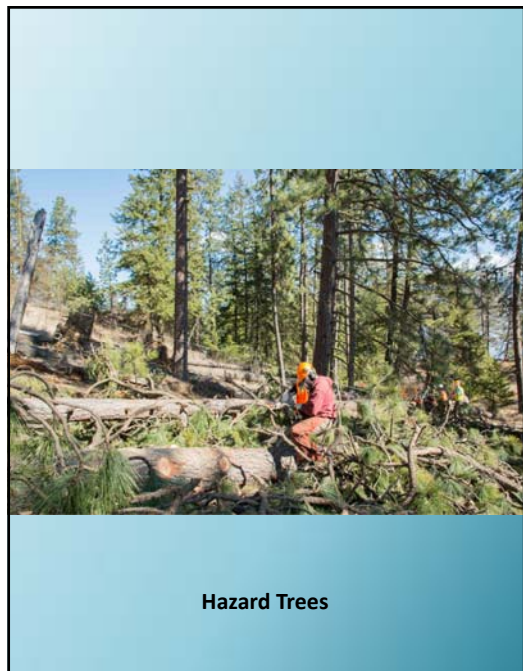
Acts as the public liaison for the urban forestry committee and assist the public with right of way tree inspections and removal/pruning requests.

Records and coordinates all efforts to maintain the cities tree city USA status.

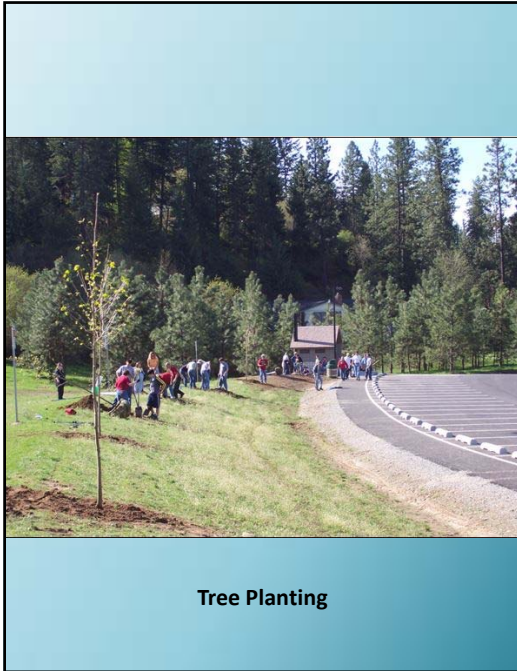

The Coeur d'Alene Parks and Recreation Department is responsible for snow removal at 40 sites throughout the city. In addition to public parks, the department clears sidewalks and parking lots at several important public buildings including City Hall, the library, the Police Department Headquarters, the Lake City Center and the Jewett House.

The parking lots that are cleared by the Parks and Recreation Department at 26 sites include 1646 parking spaces, some of which are temporarily lost due to snow storage during the season. This total does not include lots not plowed by the department, such as the covered parking at McEuen, or lots seasonally closed such as the center lot at Ramsey Park, the upper lot at Cherry Hill and part parking lot in the Canfield Sports Complex.

The amount of pavement maintained for snow removal by the department exceeds 739,960 square feet which works out to over 17 acres of parking lots and access roads.

The Parks and Recreation Department also performs snow removal on sidewalks and trails including bike trails such as the Centennial Trail, the Atlas Trail, the Seltice Trail and the Prairie Trail. Additionally, the department clears sidewalks fronting public roadways at public parks, buildings and beautification areas along with interior pathways at many of our parks to enable the citizens to access recreational opportunities. Specifically the department maintains all the sidewalks around City Hall and the Library as well as all the sidewalks at the Police Station. We also clear cross walks and sidewalks on three bridges over I-90.

The total linear feet of multiuse trails plowed is approximately 115,500 feet or about twenty two miles.

The total linear feet of sidewalks cleared is approximately 21,780 feet or a little over four miles.
