I spent a couple of years working and saving, and then I attended law school at the University of Idaho (go Vandals!), graduating summa cum laude in 2013. From the very beginning, I knew that working in criminal prosecution is what I wanted to do going forward. For nearly four years at the Payette County Prosecutor's Office, I prosecuted all manner of criminal cases, from traffic infractions to a double homicide, and everything in between. When the opportunity to work for the City of Coeur d'Alene opened up, I knew it was the perfect place for my family, and to enjoy a greater work-life balance.

What kind of training do you need to be a Deputy City Attorney?

A law degree, a functional knowledge of state and local law, a strong command of the rules of procedure and evidence, attention to detail, a solid work ethic, dispassionate and practical judgement, and the ability to work professionally with a wide variety of personality types.

What does a Deputy City Attorney do?

A deputy city attorney prosecutes all misdemeanor and infraction violations of the state and city code that occur within city limits. The one exception to this general rule is if both felony and misdemeanor charges arise out of an (Continued on page 3)
