Aggravated Assault (3): A 26-year-old male pulled a knife on a bouncer when he was denied entry at The Beacon, subject arrested; Road rage incident, the victim reported being shot at. Due to the intoxication level of the victim, no suspect or actual location of the incident was able to be obtained; A group of juveniles were partying at Super 8 Motel when an altercation occurred with a knife causing minor injuries. The suspects left prior to law enforcement arriving, active investigation.

Rape (4): All cases are active investigations.

Robbery (2): E. Best Ave. – Suspect not located; Spokane County Sheriff's Office located three suspects that had been involved in an attempted robbery in CDA, active case.

Auto Burglary (6): See map for details and locations

Burglary – Non Residential (4): 101 W. Nader Way, Safeway & 180 E. Neider Ave., Inspired Nail Spa – Male suspect forcefully entered both businesses, cash taken. The suspect has been identified, warrant requested; 611 W. Appleway Ave., Boston Brew – Attempted burglary, window broken/no entry made; E. Homestead Ave. – Attempted entry into a shed, nothing taken.

Theft (20): 6 of the 20 incidents were shoplifting. The remaining cases involved thefts from buildings that were open to the public or where the suspects had legal access. Closures: 1 - Citation / 4 – Juvenile Petitions / 15 – Reports taken.

Vehicle Theft (1): 3100 block N. 4th St. - 2016 Ford F150 (unlocked, keys left inside), located abandoned in Spokane, WA.









Density of Officer Initiated Activity Incidents / Boundary






During the month of June there were 105 offenders booked by the Coeur d'Alene Police Department with a total of 201 charges.




