<u>Aggravated Assaults (3)</u>: Two of the cases are domestic-related, and both suspects were arrested. In the third case, the victim is refusing to cooperate or provide a full statement.

Auto Burglary (3): The incidents do not appear to be related. License plates and tires were stolen from the vehicles.

Burglary - Residential (2): N Medina St. - Entry was made but nothing taken. W Canfield Ave- Entry was made and food was stolen.

<u>Theft (27)</u>: Of the 27 incidents, 15 were shoplifting cases. The remaining incidents involved thefts from public buildings or locations where suspects had lawful access.

Shoplifting case outcomes: 9 arrests/citations, 3 juveniles charged, and 3 reports taken.

Vehicle Theft (3): All vehicles were stolen and later recovered. The incidents do not appear to be related.










Arrest Statistics for November 2025


