The Finance Department received confirmation that the General Obligation Bonds for 1994 and 1996 are complete. Don Keil and Sid Fredrickson from the Wastewater Department recently attended a workshop

on threat and risk assessment. The Street Department will be starting the annual leaf pickup on November 12th. They have asked that residents do not rake their leaves into the streets until November 9th. The Street Maintenance Department also hosted the Lake City High School special needs students with a facility tour of the Street Shops. The Recreation Department has started the Youth and Adult Basketball Program with over 75 girls and boys from grades 3rd through 9th and 40 adult teams.
