PUBLIC HEARING - O-4-02 - DESIGN STANDARDS FOR THE CENTRAL BUSINESS DISTRICT: Mayor Bloem read the rules of order for this public hearing. Dave Yadon, City Planner, gave the staff report.

Mr. Yadon reported that for the past several years, the City and various citizens and business interest groups have been exploring options for implementing a design review program for

Coeur d'Alene's Downtown area. The proposed regulations presented tonight are intended to provide a basic and flexible threshold of building and site design in the downtown area. The proposal also provides for a Design Review Commission that is intended to provide for review of alternate design solutions that are not prescribed by the regulations.

Mr. Yadon noted that the proposed regulations have been reviewed by the Lake City Development Corporation, downtown interests and architects as well as other citizens and have been generally met with positive comments. The Planning Commission has

have been generally met with positive comments. The Planning Commission has recommended approval of the regulations, procedures and guidelines by a vote of 6-0.
