CALL TO ORDER: The meeting was called to order by Mayor Bloem.

INVOCATION was led by Pastor Mike Slothower, River of Life Friends Church.

PLEDGE OF ALLEGIANCE: Council President Reid led the pledge of allegiance.

PRESENTATION – PARKS AND CEMETERY DEPARTMENT ANNUAL REPORT: Parks and Cemetery Director, Doug Eastwood, provided a review of his department's

activities for the past year. He noted that the Parks Department consists of: Urban Forestry which does tree inspections and permits for removal, street-tree pruning, hazardous tree removal, tree inventory, public information and education; Building Maintenance oversees 12 municipal buildings maintaining approximately 116,382 square feet of floor space; the Cemetery staff maintains 28 acres of cemetery property, including openings and closing, funeral and burial services; the Parks team maintains 362 acres of public land, 17 parks, and

last year, hosted 189 events with 67,238 people attending those events and in the Winter they maintain public property sidewalks throughout the City.

ORDINANCE: Mayor Bloem re-iterated the rules of order for a legislative public hearing. Dave Yadon, City Planner, gave the staff report.

Mr. Yadon noted that on August 27, 2002 the City Council enacted a 120-day emergency moratorium on development on lots having a slope of 15% or greater and directed staff to prepare a Hillside Development Ordinance. Staff researched various communities for sample

regulations and prepared two drafts - the first being an ordinance presented to the Planning Commission and the second being the result of the workshops that were held following the Planning Commission review.

Public Comments: Motion by Goodlander, seconded by Edinger to limit speaking time to 3 minutes. Motion carried. Kim Cooper, 2310 Pennsylvania Ave., feels that this would be an infringement of rights based upon the State Constitution. Tim Timmons, 2857 Sugar Pines

Rd., requested the Council allow additional time for the NIBCA to review the proposed regulations before Council action. Eric Foskin, 1002 Front Ave., questioned the code stating

that a survey within 50 feet of the site be completed and wanted to know what the code means by "site"; and, requested more exhibits be provided throughout the code. Radobanko, 7500 Mulholland, Dalton Gardens, requested the Council to continue researching the requirements such as the 30' cut and fill requirement since most cut and fill

lots are in the 70'-80' range. Pat Acuff, 112 Hazelwood Dr., Mayor of Fernan Village, noted

that the biggest concern on hillside development is water quality and feels that more time is needed to further review and develop a good hillside ordinance. Ron Douglas, 214 Lakeview Drive, Fernan Village, stated that he feels that the City has the responsibility of weighing the short-term benefits that a development might bring, but rather the long-term concern of Cheri Howell, 1711 Jenny Lynn Lane, Fernan Village's Land Use hillside erosion. Consultant, feels that additional regulations need to be developed for properties within 500 feet of lake water and requested that the Council continue the moratorium for an additional 120 days and include density options in the regulations. Ed Morse, Hayden Lake, has been retained by the City of Fernan to review the City's proposed ordinance. He distributed his written review of the proposed ordinance and his recommended changes to the codes and requested the Council refer this ordinance back to the Planning Commission or other work group and extend the moratorium. Debbie Verbillis, 212 Lakeview Dr., opposes the City's proposed ordinance and feels that the City is overstepping their regulatory authority but supports the development of regulations for hillside development. Chris Buchler, 3595 Sky Harbor Drive, echoes what Mrs. Verbillis stated but added that it does need more thought. Buehl Hollister 8985 N. Hauser Lake Rd., Post Falls, recommended that the moratorium be continued so the regulations can be better developed and requested a clarification of what market value is for tree replacement. Mike Perez, 3747 E. Sky Harbor Drive, President of Armstrong Park Homeowners Association, stated that his Association are in favor of hillside regulations, the tougher the better. He noted that being a native of California, he has seen what can happen with hillside developments and the erosion it can cause without regulations. Scott Stevens, 1216 Silver Beach, has two lots on Armstrong Park, one building permit was issued, the other needed engineering studies so he did not receive the permit prior to the moratorium and is requesting permission to continue building this foundation. Karl Hartman, 3410 Lodge Pole Road, feels that hillside development regulations have already been addressed in the Uniform Building Code, and the proposed ordinance is contrary to the U.S. and State Constitutions and illegal. Janet Robnett, 701 Front Ave., representing several clients, feels that engineering guidelines for site-specific development is laudable, but creating aesthetic regulations is questionable. She suggested separating the engineering standards and aesthetic design and adopt the engineering designs now and lifting the Mike Verbillis, 212 Lakeview Drive, Fernan Village, noted that the U.S. Supreme Court states that land use regulations are not a taking of personal property. Chuck Church, 303 N. Washington, Prairie City, OR, who owns the hillside property on Fernan Lake feels that no one wants the hill to be developed so they can get together and buy it from him.

RECESS: Mayor Bloem called for a recess at 8:25 p.m. The meeting resumed at 8:34 p.m.

PUBLIC COMMENTS CONT'D: John Bruning, 618 Military Drive, spoke on behalf of the Planning Commission as its Chairman. He noted that there is a difference between developing flat lands and hillsides, including erosion. He reported that the proposed regulations direct that any major deviation go before the Planning Commission for review. Tree regulations are set for practical reasons, erosion control being one of the reasons. He noted that if the Council wishes to refer this back to the Planning Commission, they are willing to review the proposed regulations but please remember that there are time restrictions and they would need time to review. Loretta Hartman, 4110 Lodge Pole, realtor who sold Chuck Church the hillside property, noted that most of the property being affected by the proposed regulations are an R-3 zoning which would essentially change the buildable area to an R-1 zoning if these regulations are implemented. Tom Torgerson, 703 Riverside

They are not taking any position on the regulations, but urge strongly that staff dedicate more time to complete the regulations so the moratorium could be lifted in a 45-day period of time. Mike Reagen, 213 Lakeview Drive, Council President for Fernan Village, requested that development density be dictated by grade of slope and give development credits to build elsewhere. He also requested that the moratorium be continued and Council give staff direction on what specifically the Council wants on hillside development. David Taylor,
